## **Board Minutes:**

The board agreed to pay PLM the \$4000.00 – Check will be sent this week.

Membership Report: Tony updated the board on the following metrics:

• 2019 YTD Membership is 159 properties or 53%. This is equal to 2018 numbers.

**Fishing Derby:** Greg Thomes reported the first Derby committee meeting will be Monday November 18<sup>th</sup>. The liquor license that is issued by the state was denied because of the new Fishing Derby entity. The state only issues licenses to entities that have been in business for at least 3 consecutive years. With the creation of the Fishing Derby Inc; the license was denied. Therefore, ML-LPOA will apply for the license. The liquor liability policy will also be changed to the ML-LPOA. Mr. Thomes will be meeting on Friday with Representative Marion O'Neil to discuss the process of the liquor license laws for entities that have been in business for less than 3 years; for future applications. Sponsorship continues to come in. Moon Motors gave us their commitment for Side By Sides to pull the trolley.

A motion was made by Jay Sifferle to loan the Fishing Derby Inc. \$5,000 for startup costs.

**Walleye Stocking:** 400 pounds of Walleye fingerlings were releases at the Hwy 55 access on Sunday October 27, 2019.

**Lake Level:** President Graham reported on October 14, 2019 he requested the trapper remove his equipment so dismantling could begin on the beaver dam. On October 21 Mike Raiche, Brian Peterson, Bob Smith and President Graham removed branches and logs from the dam to start water flow. October 23 a contractor came in the remove half of the dam. On October 26 Mike Raiche, Bob Smith and the contractor removed the second dam downstream that consisted mostly of downed trees. On November 8 the contractor came back to the site

to remove newly accumulated debris. Water has been flowing very good. The lake level has dropped 10" since October 21, 2019. On November 9<sup>th</sup> a cleanup was organized with the help of the Boy Scouts. Bob Porter directed the many hands to remove garbage that has accumulated along the creek. A donation of \$300 was made to the boy scouts as a reward for their efforts. On November 11<sup>th</sup> Mike Raiche loaded up the bags of garbage and properly disposed of it at the city. The board decided to send a gift card and thank you card to KO Storage for their generosity in allowing the ML-LPOA to access the creek through their property. KO Storage has been very helpful with this process. Our board intention is to actively manage the creek.

**Water Quality:** An October 29<sup>th</sup> meeting was organized to discuss the direction of the Water Quality Team of Ted Pribyl and Tom Valenta. On hand at the meeting was Mike Raiche, Rob Pribyl, Tom Valenta, Ted Pribyl and Tony Graham. Through thoughtful discussion it was determined to focus on 3 main points. They are Water Quality, Weed Management and Run Off.

**Storage Shed:** Mike Raiche discussed the upcoming need for expanded storage for Gambling business. Raiche has negotiated with Chris Nelson to put a storage shed on site at Madigan's Bar and Grill. The ML-LPOA will purchase the shed. A quote from Maple Lake Lumber for a 12x16 shed has been received.

A motion was made by Greg Thomes to purchase a 12x16 storage shed for \$4,100.
