**Fishing Derby**: (Greg Thomes) Overall, we had about half of the participation that we did last year, but we were able to prove the walk on derby concept will work for the future. DNR reports have been sent in for total fish caught. Discussion around donating \$500 each to the High School After Prom committee, and the Spanish club for their support, members agreed. \$250 will be donated to Boy Scouts for their clean up efforts.

**Insurance**: (Greg Thomes) Currently the General Liability, and Director's and Officer's Liability (DOL) come from Guide One. DOL has increased, members agreed that Greg Thomes should shop for another option to keep the DOL coverage.

**Lake Level, Mill Creek, KO Storage**: (Tony Graham) Trapper not communication, but there is still beaver activity. Seeking other options to maintain Mill Creek flow.

**Water Quality Team**: (Tom Valenta) Working on grant applications for weed treatment, expect to hear back in early March. PLM in contact with Tom regarding other spraying options. Discussion around having 3<sup>rd</sup> party divers look for invasive weeds around the lake closer to summer.
