E- EWM – 2019 Treatment was 43 acres

- a. 2020 target is approximately 30 acres, maybe more.

F- Wright County Soil Water Project

- a. \$6K has been earmarked and approved for a culvert project
- b. We've spent 1500 so far on water height control at our exist culvert ditch
- c. Working on estimates for a structure through WCSW
- d. Need to take water height markings for area that we removed trees.
 - i. We think the DNR is off on their estimate of location
- e. Possible removal of fallen trees prior to ice out
- f. Beavers Brain Peterson is actively working on a new plan
