Water Quality Team: Tom Valenta discussed results of the EWM (Eurasian Water Milfoil) survey, there are 22 acres of active growth areas. PLM will act on permitting to treat these areas, estimated costs of \$36,000.

**LID:** Tom shared that Milfoil treatments will take place next week, and there will be another lake survey completed in August. Work with the DNR continues in efforts to establish the LID as the legal government entity. The Annual LID meeting will be at the Township Hall on August 6<sup>th</sup> at 9:00am, would like to see a MLLPOA presence at the meeting.
