Fishing Derby: Greg T informed the board that the ice fishing derby committee has made the decision to cancel the 2023 derby due to poor ice conditions. With only 7" of good ice, followed by 4" of poor-quality ice, many inches of snow cover and an unfavorable forecast, it would be unsafe for participants and volunteers. The fish house raffle will be postponed until the Maple Lake St. Patty's Day celebration (pending city approval).

All Pre-sold tickets will be honored for next year's derby

MLPOA Gaming: Mary P provided LG100 and LG1004 reports for review of last month's activity. December Month End per the LG100:

- 3- Line 29: Net profit \$10,936.92
- 4- Line 30: Charitable contributions \$3,730.00
- 5- Line 31: Taxes and Fees \$2,187.00

Current star rating is 4, LG1004 allowable expenses and lawful purpose expenditures were covered, including donation to the ML Irish Anglers, Boy Scouts, and the Fishing Derby.

LID / Water Quality Team: Tom reiterated information provided last month regarding grants available for water quality improvement projects. There is a cut of date off February 7th to apply to the DNR for projects that may fall under this grant program. Regarding the Weir project, we will seek permission from property owners for core sampling to be done so planning and cost estimate work can continue to move forward.

Reminder that the PLM letter was sent to property owners already, do not forget to apply for individual property weed control permits by the cut-off date.

A motion was made by Jay Sifferle to continue the 25% rebate program in the same format as last year.

A 2nd was made by Betty Tomes.

All were in favor, the motion carries.

There was discussion regarding providing a similar 25% rebate to property owners that wish to purchase product and apply on their own, with a potential cap of \$100 per property. Gordy agreed to contact local vendors regarding product costs and availability. Rob Pribyl asked for a motion to add this rebate to our weed control plan for the lake, with the intent of finalizing details in the next few meetings.

A motion was made by Jay Sifferle to start a 25% rebate plan for self-application for weed control.

A 2nd was made by Betty Thomes.

All were in favor, the motion carries.
