Water Quality Team: Gordie P spoke with both local (Maple Lake and Buffalo) vendors, they will both offer MLLPOA pricing on weed control products for homeowners. The Buffalo Country Store will again be on hand at the Spring Meeting (May 6th at 9:00 am) with product for sale. We will be offering a rebate for homeowners that apply the product and submit receipts to the MLLPOA P.O. Box by Labor Day.

Do not forget to apply for individual property weed control permits by the previously mailed cut-off date.

The fish house removal deadline for inland waters in the southern two-thirds of the state is by 11:59 p.m. on Monday, March 6

LID: Bob P said the grant request for the weir project has been submitted. Stantec has provided updated plans, but still needs to get a sign off on the easement prior to getting DNR approval.

Directory (Tony) led a discussion regarding the directories and having the ML Messengers do them again this year. We will look into the possibility or the ML Messenger handling the mailing of the directories as well, however we will have to determine the cost before approval.
