Disbursements were \$355.40 for web hosting and maintenance, \$43.09 member rebate, \$900 payment for bog removal, \$154 annual PO Box rental, and \$86.33 in credit card processing fees. The ending balance was \$88,451.17.

Total related cash including the MLID and Derby was \$135,801.29.

Membership stands at 144, with total dues collected at \$9060.00.

- Outflow options were discussed (Coordinated w/ DNR, WCSWD, Stantec Engineering, Minger Contractor):
  - Clean/dig out outflow side of weir to Hwy 55
  - Widen the weir opening to increase flow during high water events
  - Waiting on a hydrology report on impact of widening the opening
- Bog/Debris clean mechanically removed twice, multiple times by boards member hands
- Considerations high waters downstream reducing outflow, pinch point at the culvert under 53<sup>rd</sup> St. NW paralleling Hwy. 55
- Annual LID Meeting 9am on August 2<sup>nd</sup>, 2025, at Maple Lake Township Building
